### **What have we been doing in June?**

The MC has been focused on the remaining documents to go before Council, such as the MC Report and a new – and much shorter - Business Plan. The second batch of Council papers was sent out by the deadline of 17<sup>th</sup> June. No Amendments were received to the six Resolutions, although the ACA submitted a number of comments which have been circulated. Postal votes must be received by the S-G by 10<sup>th</sup> July.

## MC Topics completed/ closed this month

135 – Plate format for 2012 ACWC. Working document agreed and passed to the ACA by WCF event lead.

137 – MC Report to Council. Drafted, revised, approved and sent to Members

139 – Business Plan drafted, revised, approved and sent to Members

140 – Discussion document drafted to respond to ACA proposal to 4GB meeting, however 4GB have decided to defer for a year so closed for now.

143 – Combining wildcard and Qualifier entry processes. Proposal made, discussed and rejected.

## Open topics

126 – Wild Card selection criteria – refinements suggested for inclusion in revised Sports Regs.

133 – Investment proposal. Suggested investments to implement the agreed Investment Policy revealed a range of attitudes to risk among the MC members. Needs more work

138 – Insurance – a quote is being considered and also whether the WCF needs it

141 – Development Director – proposal to create new role of Dev Director, to help increase focus on development

142 - GC WTC formats and principles/ priorities – trying to home in on several competing aims

144 – Discussion of specific lateness policy requested by Organising Committee for GCWC.

**Tournament Group** (Ian Burrige lead) – following the GC WTC format consultation (12 responses received), a couple of format options have been debated further and potential hosting suggestions considered.

**Website Group** (James Hawkins lead) – the new site is being sorted out on a test server (on James' laptop). Once it seems reasonable it will be uploaded for review.
